I am a ggggranddaughter of Barthenia Chadwell Cottrell, daughter of David Chadwell and Elizabeth Turner, and wife of Jeremiah Skelton (her second husband). She was a widow of Moses Cottrell who was killed in an accident.

I am attaching genealogy of Jeremiah. In your information at <http://www.geocities.com/Yosemite/5273/chadwell.htm> you have him listed as Jerome. This is incorrect. Barthenia and Jeremiah moved to Joy, Livingston Co., Kentucky where they are buried. When I was fifteen my grandmother and family went to Kentucky and found Barthenia's tombstone in a pasture. This was the first evidence of her connection to the Chadwells and that she was born in Henry Co., Va.

Jeremiah is the son of John Skelton (1754) and Catherine Hepler of Luray, Page Co., Va.

Also David's wife Elizabeth is the daughter of John Turner. Her sister was Jessey Turner. This is established by John Turner's will. I have a copy of John Turner's will. Elizabeth and Jessey inherited a town from their father, I believe it was in Pittslyvania or Henry Co., Va.

Hope this can be updated in your database.

I have also attached information on John Chadwell and his family. This was researched by my grandmother who left me her information. She worked with Sharon Chadwell Phillips on her book, Chadwell Heritage. I understand she has a new edition out.

On the motion of Jeremiah Skelton and Bathena his wife late the widow of Moses Cottrell deceased by their attorney it is ordered that Joshua Ewing, Samuel Ewing, William Huskell, Moses Ball, and Abraham Lock, or any three of them do lay off and assign to the said Bathena Skelton late the widow of the said Moses Cottrell her Dower in the land of her late husband Moses Cottrell deceased in this County and make report thereof to the said court.

On this 17th day of May A.D. 1851 personally appeared before me a Justice of the Peace within and for the county and State aforesaid Capt. Jeremiah Skelton, aged 73 years, a resident of said county and State, who being duly sworn according to law declares that he is the identical Jeremiah Skelton who was a Captain in the 94th Regiment of the Virginia Militia in the regiment commanded by Col. John Preston and sometimes by Major Bradley and Major Smith in the War with Great Britain declared by the United States on the 18th day of June A.D. 1812; that he was called into requisition at Leigh County, Virginia, on or about the month of July or August 1814, and marched from home in the month of February, 1815, toward Norfolk, Virginia; that from the time he left home till he got back was one month; that he served faithfully and until he was ordered out of service by his commanding officer as will appear by the records on file at Richmond and, as he supposes, in Washington City.

He makes this declaration for the purpose of obtaining the bounty land to which he may be entitled under the Act of Congress granting bounty land to certain officers and soldiers who have been engaged in the military service of the United States passed September 28, 1850, and that he has never drawn any bounty land from the United States under any law of Congress.

Following are some extracts from the Service Record of Jeremiah Skelton. Source: National Archives, 1962.

"Capt. of Capt. Jeremiah Skelton's Company, 94th Regiment, Virginia Militia, War of 1812."

"Muster Roll Feb. 8. to March 6, 1815, dated Seven Mile Ford, Washington County., March 6th, 1815. He was present.

"Company Pay Roll 1815 Allowing six days for travel, 122 miles, from rendezvous in Lee Court House to General Rendezvous. Feb 8 to August 8, 1815 Capt. Jeremiah Skelton's Company, detached from 94th Regiment, County of Lee. He was present.

His signature is on one of the items.

One item refers to Bradley's Regiment.

You probably have this, but I saw it and it spoke of a Jeremiah, and you know that alerts me.

Dear Mrs. Bonney :

I was in Frankfort last week and looked for information of Jeremiah Skelton.

In the correspondence file there is a folder on Skelton but no Jeremiah is mentioned.

On the Boone County Tax List for 1817 and 1818 he was listed for 40 acres of land, 6 horses, 4 blacks. No family indicated. He does not appear again on the list. As yet I have found no evidence of his Judgeship. Will continue my search.

Jillson, Kentucky Land Grants, page 722, indicates that he received 200 acres of land in Livingston County, Kentucky. Also 90 acres; both tracts on Buck Creek.

Boone County records have no deed showing that he either bought or sold the Boone Country 40 acres. Perhaps the deed is filed in Livingston County. I could not find him in any of the death records at Frankfort. The name Sebree is common in Boone County; but I find no Seebree Skelton. Am in the process of examining the Circuit Court Records from the beginning of the County and may find something. Will keep looking.

Now, I need something. Is there an 1850 Census of Ingham County, Michigan, available in Washington? I would like record of all Fitzgeralds, Leets, oir Leiths. I do not know how much of a job this is as I have no idea of the size of the county in 1850. Will be glad to pay your fee for this as I feel that I have helped you much so far.

In the 1850 census for Lee County, Va. there were several families of Duff. There was a James Duff, age 93, born in Ireland. There were Duff families in Lee County in the 1820 census. - esb.

Note: Is this William Chadwell the husband of Catharine? Why is he living with someone else? I gathered the impression from a Mr. Cloud, to whom I talked in Tazewell, Tenn. that William was not all that could be hoped for. He told me that he had been told about William appearing unexpectedly in the night at Polly Cloud's home (his sister); he would tie up his horse and go in and go to bed, and one night he was almost shot for an intruder. When I told my father about it, he remarked that there was a William Chadwell with the Jesse James gang. Of course, he could not be the same. That William Chadwell was born in one of the midwestern States, which I have forgotten now, but at the time I looked it up. It is in some of the Jesse James books. - ESB.

Dear Mrs. Braun:

I am glad to have your letter of May 13, 1958. I am curious to know how you got my address. I enclose my check for \$3.25 - extra 25 cents to cover postage. I shall be much interested in your account of the Chadwell family.

My middle name is Ewing. That is derived from two sources, the principal one is from Mary Ewing who was David Chadwell Cottrell's wife. She was the daughter of Samuel Ewing of Rose Hill, Lee County, Virginia. Two present day towns in Lee County are Ewing and Rose Hill, derived, obviously, from Samuel and his home farms. My mother's mother's mother was a widow Ewing when she married my great grandfather James L. Johnson.. I am therefore listed twice in the Ewing family history and I am listed also in the Johnson family history. Of course you know that old David Chadwell, the original, moved to Tazewell from Lee County late in his life.

I am sure my first cousin, Dr. Frank T., Rogers, who is an x-ray specialist in Knoxville, Tennessee, would be interested in the Chadwell history. He is the son of my father's oldest sister Mollie who married first Canby Rogers and second Jesse Rogers, Canby's younger brother, who was Frank's father.

We have two sons, James Ewing Cottrell, Jr., and David Chadwell Cottrell, whom we refer to as the II. At least he is the second in our direct line. As prolific as old David Chadwell Cottrell was he may have had other descendants named David Chadwell Cottrell, but I do not know of them. Dave is a third year medical student at the University of Pennsylvania where I went to school. Jim, Jr. has two sons, the older of whom is James Ewing III, the other boy is name for his mother's side of the house.

I do not know of the Cottrell from Plano, Texas, but my father used to correspond with J.D. Cottrell, a lawyer of Amarillo. You probably know of the Cloud family of Claiborne County who were related by marriage to David Chadwell Cottrell. The given name Gray appears in both families; my father had a cousin named Gray Cloud.

Know all men by these presents that we John Jameson and Jeremiah Skelton are held and firmly bound unto the Commonwealth of Kentucky, in the penal sum of lb 50 curret money of said Commonwealth the payment of which well and truly to be made we dind ourselves our heirs executors and administrators jointly and severally, firmly by these presents, sealed with our seals, and signed this 28th day of April, 1824. The condition of the above obligation is such, that whereas there is about to issue from the clerk's office of the Livingston County Court, a license for a marriage shortly intended to be solemnized between the above bound John Jameson and Malinda Skelton. Dear Mrs. Bonney:

I am enclosing to you copy of 2 deeds - Jeremiah Skelton to George Rowland, and Skelton Heirs to Susan P. Willis; also I find that the following conveyances supposed to be the same 200 acres of land that Jeremiah Skelton sold his interest to George Rowland:

April 10, 1799, Deed Book 1, page 147 - Arthur Campbell of Washington County, Va. to Moses Cottrell of Washington County, Va. 260 acres seems to be part of same land January 4, 1817. David Chadwell to George Rowland 200 acres on Indian Creek seems to be the same land. Consideration in this conveyance for the love and affection that David Chadwell bears toward George Rowland for having married his Grand Daughter Betsey Cottrell - Deed Book 3, page 234.

I also find that Susan P. Skelton married John S. Willis of Lee Co., Va. and that Mrs. Willis died about the year 1868. Mr. Willis, I understand, died a short time before his wife. They left a number of children. Dr. T.B. Ely who lives here in Jonesville, Va. is a Grand Son of John S. and Susan P. Willis; also Mrs. Mollie Rose of Ewing, Va. who lives on or near to these tracts of land mentioned in the deeds is akin to the Willis's and Skeltons who would be glad to give you information regarding the Skeltons. (I believe Mrs. Rose was a Willis). I do not find anything on record here regarding Jeremiah Skelton's father. It seems to me that Jeremiah Skelton might have acquired this land or an interest in the same from his wife or his mother who might have been a Chadwell or Cottrell or a Rowland. This land lies in the Rowland, Willis, and Chadwell settlement in Lee County known as Powell's Valley and Cumberland Mountain on India Creek about 25 miles west of Jonesville, Va. and 5 or 6 miles east of Cumberland Gap, Tenn.-Va.

SKELTON CEMETERY

unmarked

This cemetery is located in Livingston Co., Ky. on the farm now owned by Willis Noel and once owned by Jeremiah Skelton, who came from Lee County, Va., through Boone Co., Ky. to Livingston Co. about 1819. To reach it, turn right on an unnamed, unmarked dirt road from Rd. #133 from Joy to Lola, or left from Rd. #135 from Joy to Hampton. It is in a pasture off the dirt road in a grove of trees, and when located all stones were down and buried. After some digging, the following graves were found:

Barthenia Skelton who was born in Henry Co., Va. died Livingston Co., Ky. June 29, 1848 in the 73 year of her age.

Alexander, son of Jeremiah Skelton, born May 16, 1805 died August 28, 1830, age 25 years 3 months.

Dr. Sebree Skelton, born December 26, 1816 died Nov. 1, 1881 "Absent, Not Dead"

The wording is as given on the stones.

The grave of Jeremiah Skelton who died around 1852 is supposed to be in the same cemetery but so far his stone has not been found.

Barthenia Skelton was the daughter of David Chadwell, a Captain in the Revolution from Henry Co., Va. Another daughter of David Chadwell, Nancy Brittain, died in Mason Co., Ky. July 19, 1852, age 70. (See Vital Statistics - Mason County, Deaths, The Register, Kentucky Historical Society, V. 63, #1, January, 1965, p. 76).

When this had been completed and returned to the land office it was registered and a land patent was issued to the owner within six months. Applies only to lands east of the Mississippi. 1816-1873.

Dear Eda,

Your welcome letter came last week. I had about concluded that you had left the U.S. Thanks so much for the Star clippings about Jesse Padon Crawford. Yes I knew him. I was a schoolmate at the Hampton Academy in 1891. Jesse was a nice looking young man well-mannered and likeable and at that time had quite an educational start. He taught District School at Crawford School House. I expect named after Dr. Crawfords' farm since he owned about 400 acres where now is heart of the town of Hampton. Dr. John C was our family physician and I expect he saved mine and mother's life when we had a serious attack of bloody flux. I judge was a good doctor for his day honest and a christian. His wife Mary was Uncle Billie Padon's sister and he was Uncle Willis Champion first cousin and was a native of old Livingston. Jesse's family was partly reared in Livingston County and the younger ones in Marion Crittenden County. Jesse has a younger brother who is a doctor in Ky. Jesse left the Academy the same year I did. I never saw him again. I went to a new school at Valporaiso Indiana while he went for a new location in Washington, D.C. and made it his permanent home. I always liked Jesse. And am glad he did so much for his friends in his law practice. I expect nearly all of his family is dead. I boarded with his sister and brother in law at Hampton School. Both of them are dead. Bro Jimmie Robinson was paster of Good Hope Baptist Church and had a stroke one day in the pulpit. He lived about a year after and his wife "Miss Lee" as we called here died soon after. Miss Lee was the music teacher.

"Are having a nice bright day, have only had one rain enough to make mud. Frost came and got our few tomatoes and blackeyed peas if it had not been for our peas we would have almost starved for beans died early only had a few messes of beans it was so dry that they died. Think of it. I was over at your old home last Sunday. Ina took me to the Christian Church at Salem 10 miles up the road and as we came home we stopped at here grandmother Jackson's ate fried chicken potatoes corn bread and old time chicken gravy. I can't express how much I enjoyed being there and I felt mother and father Jackson gave me such a hearty welcome. They are poor people but they are sincere and I always feel at home. People are so changed here from that they were when you lived here. One hardly knows whether to go in a home or not. Laura Shouse always told me to come when I wanted to and I was welcome. I have not been there since I was crippled. It is so much trouble to get me in and out of the car. When I got to church two of the members came out put me in a camp chair and took me up stairs to the church proper about 12 steps and then down a long aisle. Bro Chrystie calls it the Sanctuary. He was raised in Vermont and the Green Moutain Boys does not talk like we do. He is several times removed from Mod Anthany Wayne of History Lore. Quite young bright a good mixer and pleasant. I wonder how he ever got as far west as old Kentucky. This Bro Chrystie's first year and he has made many friends. Effie Thompson Uncle John Chittenden's daughter says that Chrystie is the "preachenest man" she ever heard. I don't know about it, but he does fill the pulpit. I do not mean in size as he is no giant like "goliath".

Maude and Bill Skelton came up evening last week. Maude brought me two pieces of pumpkin pie, real good and spicey. Maude likes to cook and divide. She likes to cook for "Bill". If she thought he was hungry she would not rest till she flew in and cooked him something real good. And she ought to because Bill deserves it and is as good to her as he can be. She and Bill belong to Bethel Church and they are not sleeping members but are alive awake and working. Their paster a young man is Bro Webster. I don't know if he is a descendant of Noah or Daniel. Maybe far far removed. Now to get down to brass tacks don't fail to come by and see us. If you should eat a bite with us it would not throw us into a conipation fit. We have almost worn out everything but we do have 8 beds and may be we could find a place for you without putting you on the door mat to sleep.

I suppose that son of yours is going to have a real Halloween affair. Tell him my best wishes and blessings go with him and his future wife. And for Jeremiah Skelton why not hang him on the Family Tree and let him rest for a while.

My best wishes to you, the boys and My Bonney. I am trying to find out if Mr. Victor Bonney is your age or mature. Hope I find out I have already decided that his is French. If he is he must address me as Miss Senyor but he must not think that I am French because I am Welsh. Hoping to see you both soon. I await your coming.
